## Raise the minimum wage!



Branch President Johnny Corson recently joined State Rep. Joe Ciresi and state Sen. Art Haywood at a press conference calling on state lawmakers to raise the minimum wage. At the Dec. 31 event, they noted that Pennsylvania's minimum wage is currently frozen at the federal minimum of \$7.25 per hour, a rate unchanged since 2009. All surrounding states have higher rates. Ciresi and Haywood have co-sponsored legislation aimed at increasing it to \$15 per hour by 2027.

Corson said that the NAACP considers raising the wage "a fundamental step toward economic equality and racial justice in America. We feel this is a crucial civil rights issue to combat poverty and inequality. "

## NAACP to host two events for seniors to help with health insurance

Are you a senior citizen who needs help with medical insurance?

Joanne Washington, chair of the branch's Health and Wellness Committee, has put together a forum to be held on two days at two locations in Pottstown.

The U.S. government has extended the Affordable Care Act until Jan. 31, so Washington -- who also is founder and CEO of the public benefit corporation, Joanne Washington Inc. -- wants to make sure seniors have information they need.

With the recent cuts at Pottstown

Hospital, Washington said, "and all the changes at the federal level, I felt like the community really didn't know what was going on. And we knew a lot of our seniors might need help signing up. We definitely don't want them to go without the health care they need."

Independent benefits specialist Karene Johnson will break down how insurance works, the best insurance options, and how it can benefit someone long-term.

"My goal is to ensure the community has a clear understanding of their coverage options and feels

supported throughout the sign-up process," she said. Computers will be set up to help people apply on the spot.

The events will be on Friday, Jan. 16, from 11 a.m. to 2 p.m. at Mission First, 414 East High Street, and on Friday, Jan. 23, from 11 a.m. to 2 p.m. at the Ricketts Center, 658 Beech St. Light refreshments will be served.

Participants should bring ID, their Social Security number, their doctor's name, and income and household information.

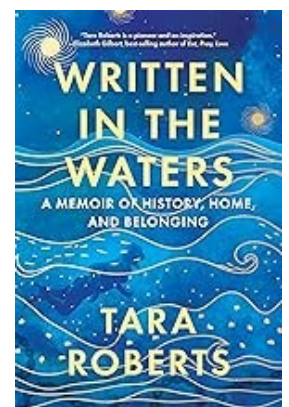

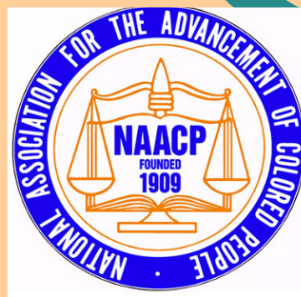
We will meet at 6 p.m. Feb. 9, at the Pottstown Library, which is holding books for us. Just ask at the desk.
