The branch will participate in Pottstown's National Night Out event on Tuesday, Aug. 2, from 6 to 8 p.m. The community block party will be at the park at Washington and Chestnut Streets. National Night Out was introduced in the 1980s, an outgrowth of town watches. The idea is to promote police-community partnerships and neighborhood camaraderie, and THAT will make our neighborhoods safer.

Many of those who have the disease need regular blood transfusions throughout their lives. The disease affects mostly African Americans, and they need blood from people who are as closely matched, genetically, to them as possible. That means other African Americans.
